**Terms of Agreement:**

1. Rental Payment- Rent is made payable to the City of Clemson and is due within thirty days (30) days of the date of notice of space acceptance by the City OR by specified tag expiration date for renewals. No deductions or allowances from the full payment will be made for unused spaces.
2. Parking Permit Tag must be displayed in view at all times reserved space is utilized. It is the responsibility of the licensee to notify the City and receive a replacement tag due to loss or theft. Any vehicle parked in a reserved space without a valid visible permit is subject to towing or fines.
3. Damage to Vehicle- City assumes no responsibility for vandalism, theft or damage to vehicles or injury to persons. Licensee accepts parking space as-is and Licensee acknowledges that City has not made and is not making any warranties whatsoever with respect to the Parking Space.
4. Licensee agrees to abide by all City parking regulations as posted or attached or adopted and all amendments and revisions to such.
5. Parking permit fee must be paid by the date of permit expiration. Failure to do so may result in permit termination.
6. Termination of Agreement: This agreement may be terminated by City immediately upon notice due to violation of any parking regulations/policies by the licensee or permitted vehicle driver. City may terminate this agreement upon thirty days notice for any reason and shall refund any balance of prepaid rental fees if termination is not due to regulation/policy/law/payment violation.
7. Licensee may terminate this agreement at any time but forfeits any and all prepaid rental fees. Licensee may transfer permit to another party subject to City approval and transfer fees.
8. Governing Law: This agreement is subject to be governed by and conforming to the laws of South Carolina.
9. This agreement is renewable and remains in effect without further action upon renewal payments paid and received by the current payment due date.
